**SPRING Application – Deadline is May 15<sup>th</sup>**

Cost of dust mitigation is **\$2.20 per lineal foot per application** (plus GST). If the applicant elects to have a second application completed an additional form must be submitted. The minimum length of application is 400 feet (121.9 meters).
