# 3. NORTH AMERICAN INVASIVE SPECIES MANAGEMENT ASSOCIATION

Fieldman MacKay stated that Assistant Fieldman Anderson is the Alberta Association of Agricultural Fieldsmen delegate to the North American Invasive Species Management Association and Assistant Fieldman Anderson requests to attend the North American Invasive Species Management Association conference in Wyoming.

Assistant Fieldman Anderson provided the following details of the conference:

- The date of the conference is August 28<sup>th</sup> to August 31<sup>st</sup>.
- Montana weed control would be there and provide information about cheat grass control.
- Information can be obtained about mapping and bio-control among other things.

Fieldman MacKay spoke to ASB Resolutions, providing the following information:

- Presented a spreadsheet to be filled out in regards to the decisions on grades.
- The information would be forwarded to Jason Storch.
- Asked if there was anything for Agricultural Service Board of the Province delegate, Garry Lentz, to carry forward.

Vizzutti expressed concerns in regards to evasive species resulting from the recent flooding.

## 1-13 Weed Control in Provincial Waterways

Member Wilson stated there are agreements between the province and 28 municipalities; \$10 000 does not seem adequate.

Fieldman MacKay provided the following information regarding ASB Resolution 1-13:

- We deal with Brian Lange, Alberta Public Lands.
- Bed, shore and public land budget is \$5000, plus \$1000 for work done on bed and shore within Fort Macleod.
- It is not a lot of money but they are not providing more in their response.
- There is no problem justifying the \$5000; there is no disputing what property is public land.

Fieldman MacKay stated 10 acres in Fort Macleod requires 3-4 people for 2 afternoons.

Member Wilson asked if the weed situation at the Fort Macleod proposed police college properties had been addressed.

Fieldman MacKay stated that the bulk of it is in crop; it is not in weeds and it will not blow away.

# 2-13 Inclusion of all Invasive Hawkweed Species as Prohibited Noxious under the Alberta Weed Control Act & Regulation

Member Sundquist stated that it has been reviewed as requested.

Chairman Hemmaway asked if more money should be requested?

Vice Chairman Alm agreed that a review was requested and it has been reviewed.

ASB decided that this was found acceptable.

## 3-13 Reporting Rats

Fieldman MacKay provided the following information regarding ASB Resolutions 3-13:

- The act would require amendment to do what resolution requires and recommended protocol.
- It is not in the act and the act would have to be amended.
- When Medicine Hat had pest control issues pest control companies were called.
- Companies were not required to report details but companies could be requested to report details.

ASB decided this was acceptable.

#### 4-13 Wild Boar Eradication Initiative

Fieldman MacKay stated wild boars are breeding and creating problems in northern Alberta.

Chairman Hemmaway stated that they could do a lot of damage.

Fieldman MacKay stated that only 8-10 farmers are raising wild boars.

Fieldman MacKay stated that it is illegal to raise rats; a permit is required to obtain them for research and proposed the same for boars.

Chairman Hemmaway asked if there is wild boar hunting.

Fieldman MacKay answered yes and they try to fence them in.

Vice Chairman Alm stated that with money involved some people would not want to terminate boar hunting and a resolution is nearly impossible.

Member Sundquist stated that with money involved there will be people that will not want to get rid of them.

Vice Chairman Alm stated that people pay big money to hunt wild boars.

Assistant Fieldman Anderson stated raising wild boars was proposed as a diversification of agriculture.

Member Sundquist stated eradication is necessary.

Assistant Fieldman Anderson explained that once out of the fencing the wild boars are hard to hunt.

ASB decided it was unsatisfactory.

## 5-13 Agricultural Pests Act Review/Invasive Species Act

Fieldman MacKay stated zebra mussels and other non agricultural pests brought the need for review found on boats brought this review forward.

Fieldman MacKay provided the following information regarding ASB Resolution 5-13:

- Mussels will not survive more than 3 days out of water.
- Not an agricultural issue.
- Pest Act is only legislature to address issue.
- Transportation has not addressed issue.
- Concerns farmers if irrigation is blocked.
- Pest act now maybe invasive species act in the future.

Vizzutti stated municipal affairs should deal with it.

Member Van Hierden stated that he knows Waterton Parks conducts checks and other places are starting to address it.

Vizzutti stated that some department needs to address it.

Fieldman MacKay stated that if transportation does not address it enforcement will be difficult.

Vizzutti stated that Idaho parks system enforces it.

Vizzutti stated that once mussels are in they are difficult to eliminate.

Chairman Hemmaway stated unsatisfactory.

Vice Chairman Alm stated that it will be everyone's problem.

Vizzutti stated that someone needs to step up.

ASB decided unsatisfactory.

## 6-13 Composition of Soil Conservation Act Appeal Committee

Fieldman MacKay provided the following information in regards to ASB Resolution 6-13:

- Not stated in the act.
- It will be looked at when it comes up for review.

Member Wilson asked how current soil maps types are built in Alberta.

Fieldman MacKay stated information used is compiled from assessments completed years ago.

Member Wilson asks if there is mapping that classifies soils and if it could be used for municipal development.

Fieldman MacKay answered that there is no sub quarter mapping that is current.

Vizzutti expressed concerns regarding traffic issues and stated it is not in legislature.

Vice Chairman Alm suggested taking this to AMD&C.

Fieldman MacKay speaks to ASB Resolution 12-13.

Chairman Earl stated they are cutting back.

Fieldman MacKay stated some engineering and maps can be done at a desk top and there is less need to spend time in the field.

Member Wilson asked if there would be more programs opened through growing forward.

Fieldman MacKay stated it would need to be opened by August to have impact on any fall work.

# 8. <u>PATRICK RAMSEY, Business Development - Alberta Agriculture and Rural Development</u>

Patrick Ramsey provided information to the ASB:

- o 30 Positions cut in ARD
- o Livestock has now been put in a new division.
- Cattle are thinner than normal this spring due to low protein in the hay fed this winter. Recommends feed test and balancing rations to ensure adequate nutrition for optimum fertility and rebreeding.
- Copy of the list of feed test labs was given and suggested the ASB have a feed test probe available to rent out to producers.
- High River veterinarians diagnosed Trichomoniasis in cattle that had been out in the Forestry Grazing Allocation west of Turner Valley. Anyone going into a forestry or community pasture should be aware of Trichomoniasis and take appropriate precautions.
- o Copy of the publication guide for 2013 was provided.
- AgriProfit\$ cost of production data for southern Alberta for 2010 information was provided. Also included was the attached article AgriProfit\$ Cost & Returns Profiles information.
- Cowbytes ration balancing program is available for \$50.00 www1.agric.gov.ab.ca/Sdepartment/deptdocs.nsf/all/agdex12486
- Beef Info Exchange Program (BIXS) is a great program for producers to learn more about how their calves perform in the feedlot and on the grid pricing system. There are plans to do a BIXS workshop across the province this winter.
- Working on Growing Forward Sainfoin project over the next three years encouraging the adoption of more grazing tolerant cultivars of Sainfoin mixed with Alfalfa to mitigate bloat risk and boost pasture productivity and livestock profitability.
- Tremendous read ranges on tags through an experimental GPS project. They were able to track the cows in the United States through tag readers.

Fieldman MacKay stated the manure spreader rental unit is about ten years old now. He said there is approximately \$5,000 dollars of repairs and maintenance put into the unit over the past 5 years.

MacKay asked the ASB if the manure spreader should be kept for one more year, sell it, replace it or to even continue having it as a rental unit.

MacKay stated a new unit would cost around \$35,000 - \$40,000, vertical beaters versus horizontal beaters.

MacKay stated there was a resolution in the past, whether or not to continue with rentals at all.

Councillor Neufeld stated Ritchie Bros. possibly may have some up for auction.

MacKay stated that Cattleman's Corner rents their manure spreader out for around \$250.00 per day.

Van Hierden stated Flamman's rents the manure spreader out for about \$300.00 per day.

Moved by Councillor Sundquist for Fieldman MacKay to bring back some quotes for both a new vertical and horizontal manure spreader.
