SPECIAL TAX INFORMATION

In 2021, the MD of Willow Creek No. 26 proposed numerous infrastructure projects within the Hamlet of Granum through funds raised from the Special Tax Bylaw. We are pleased to advise that the following projects were completed:

Projects
Granum water plant surge protector, distribution pump “variable frequency drive” (VFD) commissioning and other improvements
Tree maintenance along Lansdowne Street, Dufferin Street and 2 nd Avenue
Surfacing works in failing areas inclusive of asphalt roadways, sidewalks, and curb and gutters
Rebuild of Railway Avenue from Highway 519 to Grey Street
Weed and vegetation management
Infrastructure data collection

The 2022 Special Tax Bylaw (Bylaw 1930) will again raise \$235,000 for infrastructure projects. Planned projects for this year include:

Projects
Sanitary sewer lining and manhole renewals – Laneway south of Grey Street, Lansdowne Street, and Dufferin Street
Granum water plant – fire pump VFD replacement
Granum water plant - vault working/access platform
Granum water plant – chlorine analyzer
Sidewalk replacement – 2 nd Avenue and Lansdowne Street
Curb and gutter replacement – Lansdowne Street
Fire hydrant additions (2)
Tree maintenance along 1 st Avenue, 2 nd Avenue, 3 rd Avenue, Railway Avenue, and west of Mountain View Place
Weed and vegetation management
Water leak repair on Railway Avenue
