MUNICIPAL DISTRICT OF WILLOW CREEK NO. 26 IN THE PROVINCE OF ALBERTA BYLAW NO. 1929

BEING A Bylaw of the Municipal District of Willow Creek No. 26 in the Province of Alberta, for the purpose of authorizing the rates of taxation to be levied against assessable property within the Municipal District of Willow Creek No. 26 for the 2022 Taxation Year.

WHEREAS, the Municipal District of Willow Creek No.26 has prepared and adopted detailed estimates of municipal revenue, and expenditures as required, at the Council Meeting held on April 27, 2022 and

AND WHEREAS, the estimated municipal revenues from all sources other than property taxation total **\$4,786,885.00** and:

AND WHEREAS, the estimated municipal expenses set out in the annual budget for the Municipal District of Willow Creek No.26 for 2022 total **\$15,369,076.00**; and the balance of **\$10,628,800.00** is to be raised by general municipal property taxation;

AND WHEREAS, the Provincial Policing costs are \$293,565.00;

AND WHEREAS, the requisitions are:

AND WHEREAS, the Council is authorized to sub-classify assessed property, and to establish different rates of taxation in respect to each sub-class of property, subject to the *Municipal Government Act*, Chapter M-26, Revised Statues of Alberta, 2000; and

WHEREAS, the assessed value of all property in the Municipal District of Willow Creek No.26 as shown on the assessment roll is:

NOW THEREFORE, under the authority of the *Municipal Government Act*, the Council of the Municipal District of Willow Creek No.26, in the Province of Alberta, enacts as follows:

1. The Chief Administrative Officer is hereby authorized to levy the following rates of taxation on the assessed value of all property as shown on the assessment roll for the MD of Willow Creek No. 26:
